Course Description

In Leadership Ethics Applied in the Field (LEAF), we'll examine the ethics of leadership in various applied contexts. LEAF is a public speaking course. You'll learn to debate and present arguments about moral issues related to social justice, medical ethics, business ethics, and democratic deliberation. You'll also participate in the Intercollegiate Ethics Bowl competition and/or other public speaking opportunities.

What Are the Learning Objectives for this Class?

This course is designed to promote the following learning goals:

- Improve your public speaking abilities: public speaking skills are valuable in a range of different careers and paths in life, especially if you plan on pursuing leadership positions. But most people need guidance and a great deal of practice before they are proficient at public speaking. This class will focus on honing your public speaking skills. Students will often practice public speaking skills and learn strategies for improving them. You'll also participate in Ethics Bowl, a competition that requires both careful ethical analysis and solid public speaking abilities.
- Improve your ability to understand and evaluate ethical issues and arguments: Throughout this course, you'll examine and debate ethical arguments from different perspectives. You'll also learn about ethical

theories and how to apply them to concrete cases. This class will give you an excellent opportunity to practice your critical thinking skills because you'll often analyze, evaluate, and communicate complex ethical arguments.

• <u>Improve your ability to work in a team</u>: this class will often require you to work with other students to conduct research, debate, and refine compelling oral arguments.

What is Ethics Bowl?

This course is built around Ethics Bowl. Here's one description of what Ethics Bowl Involves:

Ethics Bowls are competitive yet collaborative events in which students discuss real-life ethical issues. In each round of competition, teams take turns analyzing cases about complex ethical dilemmas and responding to questions and comments from the other team and from a panel of judges. An Ethics Bowl differs from a Speech and Debate competition in that students are not assigned opposing views; rather, they defend the position they actually hold or think is reasonable, provide each other with constructive criticism, and win by demonstrating that they have thought rigorously and systematically about the cases and engaged respectfully and supportively with all participants.¹

More concretely, Ethics Bowl is a competition in which you and your team will deliver an oral presentation to a panel of judges in a timed and structured format. You'll also need to respond to objections from the competing team and questions from the judges. Your competitors will be teams from other schools. If possible, every member of the class will participate in an intercollegiate Ethics Bowl or similar public speaking event.

First and Second Ethics Bowls (350) You'll participate in two ethics bowls. You'll need to provide an oral presentation that analyzes a case and you'll then engage in a conversation with your classmates about this case. I'll provide you with the cases before your presentation and you'll need to prepare for all of them, drawing on the case research and analysis that you and your fellow students have provided. The first ethics bowl is worth 150 points and the second is worth 200 points.
